2. Background to the agreement

The previous frameworks for both Molecular Biology and Laboratory Chemicals expired on 30th June 2019. As these two frameworks contained similar supplier products the decision was made with the working group to amalgamate the two frameworks. During the final year of this agreement, a working group agreed a new strategy for the provision Molecular Biology and Laboratory Chemicals under 9 lots containing 19 Sub Lots.
